2. Workshop Details

3. Participation Fee and Material Costs

- The participation fee is €85 and is payable via LikeSweden online store's available methods.
- The participation fee **includes workshop attendance** but **does not include material costs**, which are payable **on-site**.
- Estimated material costs:
 - **100-200 SEK** for a silver ring
 - **250-350 SEK** for a silver bracelet
 - **from 150 SEK** for gemstones
- Participants will have the opportunity to create **one piece of jewellery** (a ring or bracelet) of their choice, which they can take home.

4. Registration and Minimum Participants

- Participants must register no later than 31st December 2024 via Like Sweden online store.
- A minimum of **11 participants** is required for the workshop to take place.
- If this minimum is not reached by **December 31**, all payments will be refunded in full within 7 working days.

5. Right of Withdrawal

- According to Swedish consumer law, the 14-day right of withdrawal does **not apply** to events, workshops, or activities scheduled for a specific date or time (Chapter 2, Section 11 of the Distance and Off-Premises Contracts Act).
- By purchasing participation in this workshop, you acknowledge and accept that no right of withdrawal applies.

6. Cancellation and Refund Policy

- The participation fee is **non-refundable**.
- However, if a participant is unable to attend, they may transfer their spot to another person. The organizer must be notified of this change **no later than 3 days before the workshop date** via email or phone.
- The organizer reserves the right to cancel the workshop under exceptional circumstances or if the minimum number of participants is not reached. In such cases, participants will receive a full refund.

7. Participant Responsibilities

- Participants are responsible for arriving on time and following safety instructions provided during the workshop.
- Participants must pay for the materials they use during the workshop.

- Participants should treat workshop tools, equipment, and materials with care. Damages caused by negligence may incur additional costs.
